IN SUCH CASE, THE INDIVIDUAL HAVING SUCH CONFLICT SHALL RECUSE HIM OR HERSELF AND THE REMAINING COMMITTEE MEMBERS WILL SELECT A REPLACEMENT. THE RECOMMENDATION AND DISPOSITION BY THE BOD SHALL BE INCORPORATED INTO THE OFFICIAL MINUTES OF THE BOD.
